
Hi,

Jim (not one to give up), set a meeting, with the IRS Officer to discuss the offer. The outcome, was a negotiated settlement (50%) reduction of my tax.

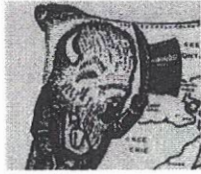
I am pleased to say, that with Jim's help, I am now current on all of my taxes.
